\$10 Bonus Promotion: \$10 bonus promotion is not available to existing RVCU Wags Kids Savings Club members or those whose accounts have been closed or unenrolled in the RVCU Wags Kids Savings Club within 90 days. Promotion is limited to the first 50 new eligible accounts opened between 4/1/2024 and 4/30/2024 and promotion can end at any time. Limit one \$10 bonus per individual. To be eligible for the \$10 bonus, open an RVCU Primary Share Account and enroll in the RVCU Wags Kids Savings Club between 4/1/2024 and 4/30/2024. \$25 minimum balance to open an RVCU Primary Share Account and to obtain the bonus. RVCU will deposit the \$10 bonus after an eligible account has been open for at least 30 days and no later than 6/28/2024.

Wags Kids Savings Club April 2024 Promotion: No purchase necessary to win. To be eligible, you must be an RVCU member, 17 or younger with parent or guardian/joint owner on account's consent, and be a Wags Kids Savings Club member. Each prize not to exceed \$50. Total value of eight prizes not to exceed \$400. Limit one \$50 prize per individual. Limit one \$50 prize per household. Other details, qualifications and restrictions apply. To Enter: The promotion periods are as listed:

All eligible existing Wags Kids Savings Club members and new eligible Wags Kids Savings Club members that submit the "Wags Kids Savings Club Enrollment Form" by dropping it off at an RVCU branch or mailing it to RVCU by the end of any Promotion Period will be automatically entered in that period's promotion and the remainder of any Promotion Periods, unless requested otherwise. The "Wags Kids Savings Club Enrollment Form" will be provided during the Promotion Periods at www.rockvalleycreditunion.org. The form will also be available in RVCU branch locations.

Eligibility: No purchase necessary to enter. Participants and winner(s) must be U.S. residents, be 17 or younger, and be a member of RVCU Wags Kids Savings Club as described herein. Must be a Wags Kids Savings Club member. Wags Kids Savings Club members who joined prior to the commencement of the Promotion Periods are eligible to participate and win. Participants 17 and under must have a parent or guardian as a joint owner on the account and such parent or guardian must consent to enter into this Promotion. Employees of RVCU, its subsidiaries, and the immediate family of any such persons and persons living in the households of each of these individuals whether related or not are ineligible to enter and win. Only one (1) entry per person per Promotion Period. RVCU Wags Kids Savings Club members may only win one prize during Promotion Periods, both current and future. Only one person per household may be a Wags Kids Savings Club winner. Winning a prize in the Wags Kids Savings Club April 2024 Promotion will not effect eligibility of the quarterly Wags Kids Savings Club Promotion and vice versa.

Drawing: Within five (5) business days following the last day of each Promotion Period, a random drawing will be conducted of all eligible entries received during the just ended Promotion Period. Prize Claims: Each winner will be notified by telephone. If a winner is disqualified or RVCU is unable to contact the winner after three (3) telephone attempts, RVCU reserves the right to conduct another drawing to determine an alternative winner or not to award that winner's prize, in its sole discretion. Winner has 14 calendar days from the date of the drawing to claim the prize. The winner must visit a RVCU branch during normal business hours in order to claim the prize. If a prize is unclaimed within 14 calendar days from the date of the drawing, the prize may be forfeited and awarded to an alternate winner.

The **BINDING ARBITRATION AND CLASS ACTION WAIVER** section contains important information regarding your accounts and all related services. It provides that either you or we can require that any disputes be resolved by binding arbitration. Arbitration replaces the right to go to court, including the right to a jury trial and the right to participate in a class action or similar proceeding. In arbitration, the dispute is submitted to a neutral party, an arbitrator, instead of a judge or jury. Arbitration procedures may be more limited than rules applicable in court.
